

**ZhongAn Technologies International Group Limited (“ZA”, “we”, “us” or “our”)
Personal Information Collection Statement relating to the Personal Data (Privacy) Ordinance
 (“Statement”)**

Collection

We may collect your personal data in connection with purposes set out in this Statement. You acknowledge and agree that you can only participate in any of our events, programme or other activities registered through this site (“**Event**”) if you accept the Statement. By submitting your application or participating in the Event you agree to be bound and accept the Statement. If you do not agree to this Statement, you must not submit your application or participate in the Event.

If the information requested by us is not provided, we may not be able to process your application or participating in the Event.

If at any time you provide us with the personal data of any third party (e.g. employees, representatives, etc), you warrant and undertake that you have obtained the consent of the relevant individual to provide their personal data to us, for us to use and transfer their personal data in accordance with this Statement.

We may also collect your information, directly or indirectly, in the ordinary course of our business, including information collected through the use of our websites, cookies or other services.

Purposes

We may use any personal data collected by us for one or more of the following purposes: (a) to process and administer your application to participate in the Event; (b) to communicate with you regarding your application, enquiries or feedback; (c) to include your personal data in any profile, content, publications, images, recordings and/or materials in any format whatsoever created by us or on our behalf in relation to the Event; (d) to conduct research and/or analysis from time to time to better understand your preferences, interests, experiences and/or habits; (e) to send you marketing materials pursuant to paragraph titled “Direct Marketing” below; and/or (f) for any other incidental or associated purpose relating to the above, or any other purposes as specified in a personal information collection statement when your personal data is being collected, or any other purposes which you may from time to time agree.

Direct Marketing

Subject to your consent (which includes an indication of no objection), we intend to use your email address and telephone number to send you information relating to (a) promotion of any Event, charity and healthcare-related activities and related services hosted or provided by us and/or any member of the ZA Group (“**ZA Group**” and any “**member of the ZA Group**” means ZA, and/or its subsidiaries and affiliates); and (b) research and questionnaires about the above Event, activities and related services .

In addition to marketing the above events, activities and related services ourselves, we may provide your email address and telephone number to all or any member of the ZA Group for use by them in marketing financial products and services, and we require your consent (which includes an indication of no objection) for that purpose.

If you do not wish us to use or provide to other persons your personal data for use in direct marketing as described above, you may exercise your opt-out right by notifying us.

Disclosure

For the purposes set out above, we may transfer any personal data held by us to: (a) any member of the ZA Group; and (b) third party service providers of any member of the ZA Group (including those that provide back-office or IT services, or marketing and promotional services or security services in relation to the Event).

We may also include personal data (including email address and telephone number) in promotional or marketing materials (including video and/or audio recordings, photographs, live streaming, broadcasts, brochures and adverts) related to the Event, which may be disseminated to and made available to the public.

We may disclose any personal data when required by applicable law, or as requested by any court, tribunal, or government or law enforcement authorities, or to bring any legal action or to defend any claim related to you.

Your Rights and Contacting us
